

Information on personal data processing

Under Article 13 (1) and (2) of Regulation (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) please be advised that:

The controller of your personal data is **Prime Car Management S.A.**, based in Gdańsk at ul. Polanki 4, entered in the Entrepreneurs' Register of the National Court Register kept by the District Court in Gdańsk, VII Economic Division at number KRS 0000013870, having the following numbers: Tax Identification Number [NIP] 957-07-53-221 and Statistical Number [REGON] 191888626, seed capital and paid capital of PLN 23 817 680.

Your personal data will be processed:

1. on the grounds of Article 6 (1) (b) of the General Data Protection Regulation, in order to take action as requested by you for the purpose of preparing and presenting an offer for the financing or sale of cars.
2. on the grounds of Article 6 (1) (f) of the General Data Protection Regulation, for the purposes of the legitimate interests pursued by the controller, and in particular:
 - a) for analytical, statistical and governance purposes, including internal reporting, statistics and analysis, aimed to prepare the best possible products for customers, optimise the processes of customer service, financial analysis, and internal audits;
 - b) for filing (evidencing) purposes with the aim to secure legally protected interests of the controller in case of a potential lawsuit or a legal need to prove certain facts to competent authorities;
 - c) for the purpose of explaining the justifiability of your complaints, grievances, requests or other queries;
 - d) for the purpose of ensuring compliance with legal regulations, and in particular regulations to counteract money laundering and terrorist financing;
 - e) for the purpose of examining customer satisfaction, the quality of customer service and the level of satisfaction on the part of customers with the products and services offered by the controller;

The controller would like to inform you that your personal data may be shared with other Masterlease Group entities (Futura Leasing S.A., Masterlease Sp. z o.o., MasterRent24 Sp. z o.o., each based at ul. Polanki 4 in Gdańsk), with entities with which the controller cooperates when providing his services, and with subcontractors; and in particular the controller may share your personal data with the law companies providing legal services to the controller should a legal problem arise requiring, in the controller's opinion, legal support in order to determine, pursue and enforce claims and to defend against claims in proceedings before courts of law and other authorities.

The Controller informs that your personal data may be transferred to entities from the PKO Bank Polski S.A. capital group, to which the Controller belongs, whose current list is available at www.pkobp.pl, in particular to PKO Leasing S.A. with its registered office at al. Marszałka E. Śmigłego-Rydza 20 in Łódź, Poland, or PKO Bank Polski S.A. with its registered office at ul. Puławska 15 in Warsaw, Poland, for the purposes of analysing and implementing of process solutions relevant for business optimization and reliable risk management of entities in the PKO Leasing S.A. Group.

Your personal data will be stored for the time necessary to take action as requested by you for the purpose of preparing and presenting an offer and for the time necessary to secure the legitimate interests of the controller in relation to claims which may arise in connection with pursuing the above aim or in connection with queries from authorised authorities related to the documents you have submitted.

The controller would like to inform you that you have the right to: request the controller to give you access to your personal data, correct or remove them, or limit their processing, as well as the right to move your personal data. You are entitled to object to the processing of your personal data.

You also have the right to file a complaint with the supervisory authority if, in your opinion, the processing of personal data violates the provisions of the General Data Protection Regulation.

It is not compulsory for you to disclose your personal data.

Based on your personal data, the controller will not make any automatic decisions relating to you, nor any decisions resulting from profiling.

In case of divergence between the language versions, the Polish version shall prevail
