

### Information on personal data processing

Under Article 13 (1) and (2) of Regulation (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) please be advised that:

The controller of your personal data is each of the Masterlease Group companies, i.e.:

Your personal data will be processed on the grounds of Article 6 (1) (a) of the General Data Protection Regulation – on the basis of voluntary consent given by you for the purpose of marketing the products and services offered by the companies relating to lease, rental and hiring of cars, as well as sale of used cars.

The controller would like to inform you that the granting of consent is voluntary, and that the consent granted may be withdrawn at any time (this having no impact on the previous legitimacy of data processing). The consent may be withdrawn by sending a statement:

Withdrawal of the consent will make it impossible for you to receive commercial information.

The controller would like to inform you that your personal data may be shared with entities with which the controller cooperates when providing the services specified in the contract, and with subcontractors; and in particular the controller may share your personal data with:

- a) advertising agencies or other entities involved in marketing activities if they are commissioned to carry out marketing campaigns or other marketing activities;

- b) law companies providing legal services to the controller should a legal problem arise requiring, in the controller's opinion, legal support.

The Controller informs that your personal data may be transferred to entities from the PKO Bank Polski S.A. capital group, to which the Controller belongs, whose current list is available at [www.pkobp.pl](http://www.pkobp.pl), in particular to PKO Leasing S.A. with its registered office at al. Marszałka E. Śmigłego-Rydza 20 in Łódź, Poland, or PKO Bank Polski S.A. with its registered office at ul. Puławska 15 in Warsaw, Poland, for the purposes of analysing and implementing of process solutions relevant for business optimization and reliable risk management of entities in the PKO Leasing S.A. Group.

Your personal data will be stored for the time necessary to secure the legitimate interests of the controller in relation to claims which may arise out of the legal relationship binding you with the controller arising as a result of the consent you gave to the processing of your personal data for marketing purposes.

The controller would like to inform you that you have the right to: request the controller to give you access to your personal data, correct or remove them, or limit their processing, as well as the right to move your personal data. You are entitled to object to the processing of your personal data. Moreover, you have the right to withdraw your consent at any time without any consequences for the legitimacy of the processing done on the basis of the consent prior to its withdrawal. You can exercise the aforementioned rights by sending an appropriate request:

You also have the right to file a complaint with the President of the Office for Personal Data Protection, if you think that the processing of your personal data violates the provisions of General Data Protection Regulation.

Providing personal data is not mandatory.

The controller would like to inform you that your personal data will be processed in an automated manner (including in the form of profiling); however, this will have no legal consequences, nor will it have any impact on your position. Profiling is a process whereby personal data are processed (including in an automated manner) by being used for the analysis or forecast of personal preferences based on data kept by the controller, i.e. the history of activeness on websites, queries sent to the controller, history of customer service. You may bring your objection to profiling at any time, by sending it to the addresses specified above. In this case the controller will not be able to inform you about offers best suited to your preferences.
